THE FACTS AND REASONS FOR ME FILING  
FOR A APPEAL IS BECAUSE

SC Court of Appeals

1. • THEY STOPPED IN THE MIDDLE OF MY TRIAL TO HUNT DOWN AND (MAKE) A VICTIM (ASHLEY MACK) COME TESTIFY AFTER SHE STATED (MULTIPLE) TIMES THAT SHE DID NOT WANT TO CO-OPERATE ANYMORE, STILL, THEY AS'N THE SOLICITOR, (MARY JONES) ORDERED FOR A POLICE OFFICER TO PULL HER OVER AND FORCE HER TO COME TESTIFY.
2. • THE FIRST VICTIM JABORI LINDEN (REFUSED) TO COME TESTIFY
3. • MY PUBLIC DEFENDER (COURTNEY GIBBS) SCARED ME IN ANY POSSIBLE WAY SHE COULD, BY ALWAYS TELLING ME I NEED TO TAKE A 15 YEAR PLEA, AND ALWAYS ACTED AS SHE WAS ON THE SOLICITOR'S SIDE AGAINST ME, TELLING ME I WILL MOST LIKELY GET LIFE
4. • THEY FORCED ME A JOINT TRIAL AFTER STATING MULTIPLE TIMES THAT (I) AND MY CO-DEFENDANT (JONAS JERRY WASHINGTON) STATED THAT WE DID NOT WANT TO DO THAT. THEY EVEN MADE US DO A JOINT TRIAL AFTER MY CO-DEFENDANT MADE MULTIPLE STATEMENTS AGAINST ME
5. • I DID NOT TRUST MY PUBLIC DEFENDER WHAT-SO-EVER, SHE DID NOT (TRY) AND SHE SHOWED ME SHE DID NOT CARE, AND THE ONLY REASON I COMPLIED WITH HER AND THE JUDGE AGREEMENT IS BECAUSE I FELT LIFE IF I FINISHED TRIAL WITH HER SHE WAS GOING TO MAKE SURE I NEVER MADE IT HOME

6. THE BURGLARY / KIDNAPPING / GRAND THEFT / AND POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME. WAS PLACED AGAINST ME ON APRIL 22ND OF 2021, BUT AT THE END OF 2023 THEY ADDED AN EXTRA ARMED ROBBERY CHARGE THAT I HAD NO KNOWLEDGE OF UNTIL JANUARY OF 2024 WHICH DID NOT GIVE ME TIME TO PREPARE FOR THE MARCH 4TH TRIAL AND IN THE BEGINNING OF TRIAL ON THE TRANSCRIPT IT SHOULD SHOW THAT ME AND MY CO-DEFENDANT BOTH ASKED FOR A TRIAL SEPARATION AND A CONTINUANCE SO WE COULD PREPARE FOR TRIAL

7. CAMERA FOOTAGE SHOWS THAT I NEVER LEFT OUT OF THE CAR WHAT-SO-EVER, SO I NEVER WENT INSIDE OF A HOUSE, DID I KIDNAP ANYONE AND THOSE ARE NOT CHARGES IM MOST CONCERNED ABOUT

8. I ASKED MY PUBLIC DEFENDER COURTNEY GIBBS FOR OR FOR HER TO TALK WITH THE SOLICITOR ABOUT A PLEA FOR 8-10, BETTER YET 10 YEARS SUSPENDED TO 5 YEARS BEING THAT I DID NOT COMMIT A VIOLENT CRIME, BUT ALL SHE KEPT BRINGING UP WAS (WOULD YOU TAKE 15), SHE DID NOT WANT TO WORK FOR ME AT ALL.

9. AT LEAST 3/4 MONTHS BEFORE TRIAL I TOLD (COURTNEY GIBBS) I DID NOT WANT HER OVER MY CASE ANYMORE AND I HAVE MESSAGES TO PROVE THE SAME, AND I ALSO ASKED HER TO CONTINUE MY TRIAL DATE SO I COULD DO SO AND SHE TOLD ME SHE WOULD NOT BE ABLE TO DO SO AND WHEN I SAID (DO SO) I MEAN (HIRE A PRIVATE ATTORNEY)


- 10 THE FEMALE VICTIM ASHLEY MACK LIED MULTIPLE TIMES IN HER FIRST STATEMENT SAYING ME AND MY CO-DEFENDANT "JONAS WASHINGTON" WENT INSIDE OF HER RESIDENCE AND RUMMAGED THROUGH THERE BELONGINGS BUT CAMERA FOOTAGE SHOWS ME NEVER LEAVING THE CAR
- 11 NO ONE AT ALL CAN SAY MY MOTIVE FOR THAT DAY WAS TO SEE THAT CRIME HAPPEN AND NO-ONE CAN SAY THAT I EVEN KNOW WHAT WAS GOING ON OR ABOUT TO HAPPEN
- 12 THE FEMALE (ASHLEY MACK) DOESNT OWN THE VEHICLE OR THE TRAILER (HOUSE) AND LIED MULTIPLE TIMES DURING HER INTERVIEW AND STATEMENTS SHE'S NOT OR WASNT EVEN A RELIABLE WITNESS BUT STILL THEY FORCED HER TO BE THERE.
- 13 THE MALE VICTIM JADORI LINNEN WHICH WE WERE AT "HIS" TRAILER, (HOUSE) WAS NON COMPLIANT AFTER HIS FIRST STATEMENT AND WANTED NOTHING TO DO WITH THE CHARGES WHAT-SO-EVER
- 14 MY FAMILY & I TRIED TO FIRE (COURTNEY GIBBS) MULTIPLE TIMES SO THAT WE COULD HIRE A (PRIVATE ATTORNEY) AND SHE WOULD NEVER COME OFF OF MY CASE

ONE OF THE VICTIMS, (ACHLEY MACKS) MOTHER  
• 15 WAS APART OF THE JURY, AND EVEN AFTER  
SAYING HER FULL LEGAL NAME, WHICH THE  
SOLICITOR WAS AWARE OF SHE WAS NOT  
REMOVED UNTIL "I" SAID SOMETHING

• 16 I DID NOT FEEL LIKE I COULD STAND  
TRIAL WITH COURTNEY GIBBS, SHE HERSELF  
EVEN TOLD ME THAT THE SOLICITOR (MARY JONES)  
DOES NOT LIKE ME OR MY BROTHERS AND HAS  
ALWAYS BEEN SAYING SHE WILL DO WHATEVER TO  
SEND ME TO PRISON.

• 17 MY CO-DEFENDANT AT FIRST TOLD INVESTIGA-  
TORS THAT I WAS THE MASTERMIND THEN  
RECANTED HIS STATEMENT SAYING INVESTIGATORS  
BASICALLY FORCED HIM TO DO SO. "I" NEVER GOT OUT  
OF A VEHICLE WHATSO-EVER AND IT SHOWS ON CAMERA

• 18 IM JUST WILLING TO ATLEAST TAKE A  
10 SUSPENDED TO 5 YEAR PLEA BEING THAT  
I PERSONALLY DID NOTHING VIOLENT WHATSO-  
EVER, AND IF NOT THAT IM JUST ASKING TO  
FIGHT FOR 10 YEARS NON VIOLENT (51%)

(SNIFFING COCAIN)

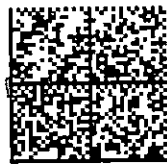
24 • HONESTLY I'M HOPING AND PRAYING THAT

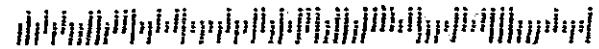
