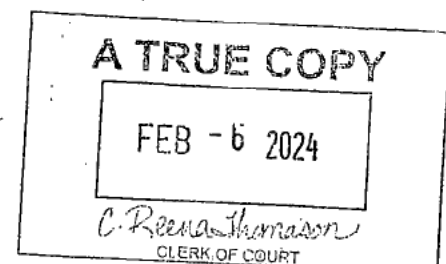
Michael Edward Thompson appeals his conviction and sentence in this case. The sentence was imposed by the Honorable Brian M. Gibbons on January 31, 2024 .

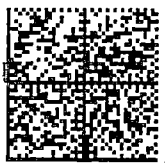
