They usually are where the word inaudible appears in either a question or answer by the witness.

Would you please have someone from your office to review the tapes and determine if any of the inaudibles can be eliminated. Would it be possible for the attorneys who tried the case to also listen to the tape to determine if the voices can be heard.

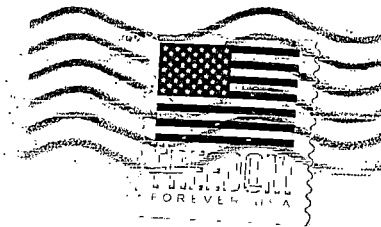
