MOTION FOR CONSOLIDATION

Pursuant to Rule 214 of the South Carolina Appellate Court Rules, Appellants Amazon.com, Inc.; Amazon.com, LLC; Amazon.com Services, Inc; and Amazon Logistics, Inc. (collectively, “Appellants”) hereby move this Court for an order consolidating this matter with *Shaw v. Amazon.com, Inc.*, Appellate Case No. 2024-000034.

On January 8, 2024, Appellants filed a Notice of Appeal from the judgment and verdict in this case. Prior to filing the notice of appeal, Appellants filed the following motions: (1) a motion for the trial court to reconsider its order denying Appellants’ request for ten days to file post-trial motions; (2) a motion for enlargement of time to file Appellants’ request for ten days to file post-

trial motions; (3) a motion to alter or amend the judgment; (4) motions for judgment notwithstanding the verdict (“JNOV”) and a new trial; and (5) a motion to stay execution on the judgment. The trial court had not ruled on these motions prior to the filing of the Notice of Appeal; therefore, Appellants moved this Court for a limited remand. On January 18, the Court granted Appellants’ motion for a limited remand.

On March 4, the trial court entered an order denying Appellants’ motion to reconsider the denial of ten days to file post-trial motions and denying Appellants’ motion for enlargement of time. On March 28, the trial court denied Appellants’ motion to reconsider the denial of their motion for enlargement of time. Appellants have now filed an additional Notice of Appeal appealing the March 4 and March 28 orders. Because the two appeals arise out of the same case, the undersigned moves as a matter of judicial economy for this Court to consolidate the two appeals. *See* Rule 214, SCACR (“Where there is more than one appeal from the same order, judgment, decision or decree, or where the same question is involved in two or more appeals in different cases, the appellate court may, in its discretion, order the appeal to be consolidated.”); *Austin v. Stokes-Craven Holding Corp.*, 406 S.C. 187, 196, 750 S.E.2d 78, 83 (2013) (consolidating appeals); *Limehouse v. Hulsey*, 404 S.C. 93, 96, 744 S.E.2d 566, 568 (2013) (consolidating appeals).
