**SHOPLIFTING- ENHANCEMENT**



Said Defendant has two or more prior convictions in which the term of imprisonment is contingent upon the value of the property involved. All in violation of 16-13-0110(A) and 16-1-57 (Penalty 16-1-57; 16-13-0110(B)(1) of the South Carolina Code of Laws (1976) as amended.


