MOTION FOR AN EXTENSION TO SERVE AND FILE

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Brief of Petitioner in the case of Johnny Haggins v. The State with the Court of Appeals on February 23, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Justen L. Wilkes v. The State with the Supreme Court on February 12, 2024. Counsel appeared before the Court of Appeals for Oral Argument in the case of Devatee Tymar Clinton v. The State on February 6, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Demetrius A. Goodwin v. The State with the Supreme Court on January 16, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.

5. On March 29, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through April 30, 2024.


