Counsel for Raheem Oquendal Grant respectfully requests to serve and file an amended Designation of Matter and an amended Record on Appeal in the above captioned case, pursuant to Rules 209, 210, and 240, SCACR. In support of this motion, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter were filed with this Court on December 6, 2023. The Initial Brief of Respondent and Designation of Matter were filed on March 4, 2024. The Record on Appeal was filed on March 29, 2024.

2. While preparing the Final Brief of Appellant, counsel discovered the Designation of Matter filed on December 6, 2023 inadvertently listed Page 655 of the trial transcript instead of Page 665 where sentencing occurs. Counsel believes this is a typographical error as Page 665 not

Page 655 was cited in the Initial Brief of Appellant. Additionally, sentencing is not included in the Record on Appeal previously filed.

3. To correct this typographical error, counsel respectfully requests leave to file an amended Designation of Matter and an amended Record on Appeal removing Page 655 and adding Page 665. The amended Designation of Matter and the amended Record on Appeal are being filed simultaneously with this motion.

4. On April 4, 2024, opposing counsel, Andrew D. Powell, kindly consented to this motion.

WHEREFORE, undersigned counsel respectfully requests the Court grant counsel's request to amend the Designation of Matter and the Record on Appeal in the above captioned case, pursuant to Rules 209, 210, and 240, SCACR.
