**MOTION FOR EXTENSION OF TIME TO FILE
APPELLANT-RESPONDENTS' PETITION FOR REHEARING**

Appellant-Respondent, by and through her undersigned attorney hereby moves this Honorable Court for a 10-day extension of time in which to file her **Petition for Rehearing**.
