

On February 20, 2024, the appellant filed the appropriate corrections to the deficiencies referenced by the Clerk of Court, where in, the appellant did state: "he was waiting on his Trust Fund Account information", of which, he immediately filed with the court on March 5, 2024 in support of his financial status to the Clerk of Court.

On April 3, 2024, the appellant received correspondence again from the Clerk of Court dated March 29, 2024 addressing the appellants filing fee, or the matter will be dismissed.

In conclusion with emphasis to the forementioned provisions Id., the appellant cannot provide the required payment in full, or in the partial amount of twenty percent (20%) within the allotted ten (10) days due to SCDC's Financial Department schedule to issue and mail checks requested for such purposes. SCDC employee's handling of such matters is beyond the appellants power and control. Also, the appellant does not have outside supportive resources to accommodate these financial matters.

Therefore, the appellant prays the court grant him grace in this motion with respect of reasonable consideration to the appellants rightful access to the courts that will allow him ample time to secure future payments of the specified twenty percent (20%) to properly pay the filing fee.

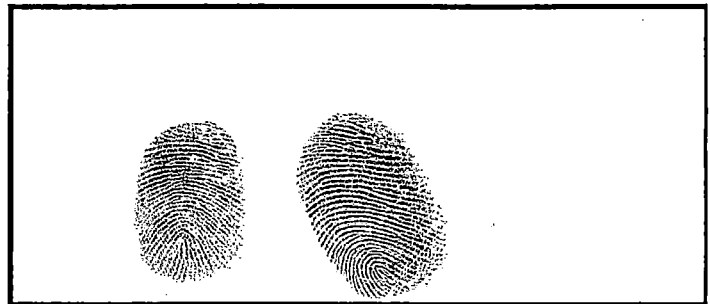

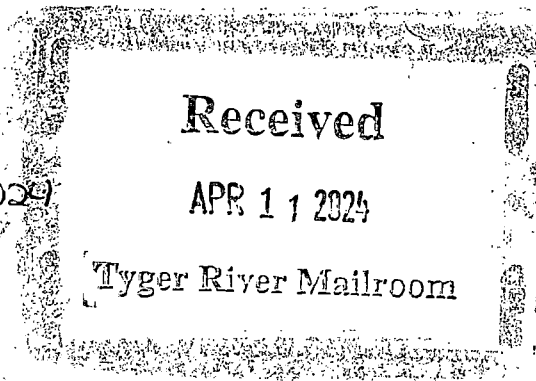

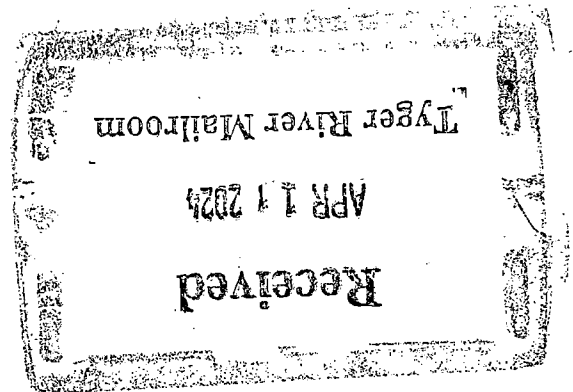
