


Enclosed for filing is a notice of appeal in the above



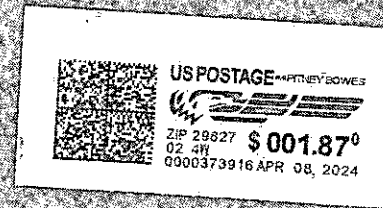
