On the day of my sentencing Mr. Shingles call the County Jail and ask them to place me under watch for whatever reason of his. I ask the Correctional Officer why was I taken out of my dorm and place on special watch they inform me that my lawyer had call and ask them to do so. So I text Mr. Shingles and ask why did he call and do such thing and because of what he done I am unable to contact anyone by the telephone. Mr. Shingles replied and said he was trying to lookout for me. I believe Mr. Shingle was in violation when he done such thing. I believe Mr. Shingle was trying to slim my chances to file a appeal. Which I was giving 10 days to do so. The next day I got to talk to the the Correction Officer over me and I told him that I don't know why my lawyer would call and tell them to place me in a cell alone and I had no intentions on harming myself or anyone else in the Jail. He had me evaluated by the doctor and they made me sign a paper saying that if I felt like hurting myself that I would tell an officer. So I sign and they tel me go back to my original dorm. So that same day I ask Mr. Shingle if he could get my transcrip for me before I was ship off. He replied and said that he had been test positive for Corona Virus and to tell someone that I may need to be quarantine. I told him OK but I need him to get my transcrip for me to help me file my PCR with and He I needed him to put in my appeal. Mr. Shingles never replied back. I was ship off to SDC and I was affriad that Mr. Shingles would not get my appeal in time. But my family stayed trying to contact him and he finally put it in on the last day that it was due on the 10th day. I believe Mr. Shingle never had the intention on helpping or he had me pledding to something I didn't do which I recieve 20 years.
