

At a Court of General Sessions, convened on October 21, 2021 the Grand Jurors of  
CLARENDO County present upon their oath:

**COUNT ONE - BURGLARY, 1ST DEGREE**

That ROBERT ASHLEY WHEELER, III did in Clarendon County on or about May 12, 2021 enter the dwelling of located at [REDACTED], Turbeville without consent and with the intent to commit a crime therein and when, in effecting entry or while in the dwelling or in immediate flight, the defendant was armed with a deadly weapon, remained in the home in the nighttime, and used or threatened to use a dangerous instrument, to wit: remained inside the residence during the nighttime, armed himself, and fired shots at deputies outside the home, in violation of Section 16-11-0311(A), Code of Laws of South Carolina, 1976, as amended.
