I am Counsel for Petitioners LG Chem, Ltd. and LG Chem America, Inc. in the above-referenced matter, which is currently scheduled for oral argument on May 21, 2024.

I am writing to inform the Court that, this morning, Respondent-Plaintiff Dwayne Thompson filed the attached Stipulation of Dismissal with Prejudice, dismissing with prejudice all claims asserted in the underlying action against all parties, including Petitioners LG Chem, Ltd. and LG Chem America, Inc., as well as the only additional party in the underlying action, Rolling Fog Vapor, LLC.

As a result of this dismissal, the parties to the above-referenced Appellate Case No. 2022-00853, agree that this proceeding should be dismissed, with each party to bear its own costs, pursuant to SCACR 260(b).
