This matter came before the Court on August 21, 2023, for a pretrial hearing and status conference. Prior to the status conference, the Receiver and Penn National Mutual Casualty Insurance Company (“Penn National”) submitted reports to the Court regarding the status of Penn National’s digitization of microfiche cards and the searchability of the database as ordered by the Court on May 5, 2022. The Court has reviewed the status reports and discussed this ongoing discovery matter with counsel. The Court hereby enters the following scheduling order:

1. Penn National shall submit an affidavit to this Court by September 11, 2023, from a senior Penn National official with complete knowledge about this matter, confirming that Penn National has digitized every Penn National commercial-line policy-related document, whether contained on microfiche or otherwise, in its possession, custody, or control, and that such documents are available to the Receiver in a searchable database.

2. Penn National shall continue to submit reports to this Court every two weeks starting September 11, 2023, regarding the status of Penn National’s compliance with the Court’s May 5, 2022 discovery order and the issues identified in the Receiver’s August 10, 2023 Report.

2. This matter will be set for trial on November 13, 2023 and a pretrial hearing set for October 25, 2023 at the Richland County Judicial Center.
