
1. The initial brief of appellant and designation of matter was filed with this Court on June 30, 2023.
2. Undersigned counsel was later notified by opposing counsel, Joseph Maye, that the trial transcript had matters out-of-order in it. In short, part of Day 3 of the trial was transcribed in front of a portion of Day 2. Undersigned counsel agreed that a corrected trial transcript

needed to be requested from the court reporter. That corrected transcript was received on October 11, 2023.

3. The initial brief of respondent and designation of matter was then filed on March 4, 2024.
4. The Record on Appeal was then timely served and filed on April 3, 2024. However, due to inadvertence, and the change in Administrative Assistants, the Record on Appeal contained the original trial transcript and not the corrected trial transcript.
5. Undersigned counsel filed his Final Brief of Appellant on the morning of April 23, 2024. However, on the afternoon of April 23, 2024, undersigned counsel was informed by opposing counsel that the Record on Appeal did not contain the corrected trial transcript.
6. Counsel therefore requests that this Court accept the filed Amended Record on Appeal and Amended Final Brief of Appellant which are being filed contemporaneously with this motion today, April 24, 2024.
7. This request is made in good faith, and not for purpose of delay.
8. Opposing counsel, W. Joseph Maye, has consented to the filing of this Amended Record on Appeal and Amended Final Brief of Appellant.

WHEREFORE, the undersigned counsel would respectfully request that this Court accept and file the Amended Record on Appeal and Amended Final Brief of Appellant in this case for the foregoing reasons.


