number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Terrance G. Adams v. The State with the Court of Appeals on March 14, 2024. Counsel filed the Anders Brief of Appellant, Designation of Matter and Record on Appeal in the case of The State v. Michael Lindsay Faile with the Court of Appeals on March 12, 2024. Counsel filed the Brief of Petitioner in the case of Johnny Haggins v. The State with the Court of Appeals on February 23, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Justen L. Wilkes v. The State with the Supreme Court on February 12, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.


