RESPONDENT-APPELLANT'S SECOND CONSENT MOTION FOR EXTENSION OF TIME TO FILE AND SERVE ITS INITIAL REPLY BRIEF AS APPELLANT AND DESIGNATION OF MATTER FOR INCLUSION IN THE RECORD ON APPEAL

AND NOW COMES Respondent-Appellant Medical University of South Carolina (“MUSC”), by and through its undersigned counsel, pursuant to Rule 263(b), SCACR, and moves for an extension of ten (10) days additional time to file and serve its Initial Reply Brief as Appellant and Designation of Matter for Inclusion in the Record on Appeal.


