Security took a deeper look into why this occurred and noted that the domain lawsonlawsc.com is about a month old and does not have some of the settings that help prove the legitimacy of the domain when sending emails. While they may have sent a few emails to start, the moment they sent the email

with the attachment, plus how the email was worded, caused the filters to immediately flag it as suspicious. The individual should probably use an alternative email to submit to ctappfilings for a short while until those issues are addressed.
