MOTION TO RECONSIDER

---

Arthur Simmons, by and through undersigned counsel, hereby requests reconsideration of the Order of the Court filed May 2, 2024, dismissing the appeal of the above-referenced case for failure to serve Respondent within thirty (30) days of receipt of the decision. Undersigned counsel served the Respondent on April 12, 2024, the same day a timely Notice of Appeal to this Court (of the Administrative Law Court's March 15, 2024 decision in this case) was deposited in the mail with the United States Postal Service. Proof of the same, including service on the respondent, is included herein. See Attachment 1 (proof of mailing to Court of Appeals and Respondent's counsel). As soon as undersigned counsel was made aware on April 19, 2024, of the deficiencies regarding proof of service, undersigned counsel remedied the deficiencies the same day. See Attachment 2 (proof of mailing to Court of Appeals, Respondent's counsel, and the Administrative Law Court).

The Appellant, by and through undersigned counsel, hereby requests the Court grant this Motion to Reconsider and reinstate the appeal of the Administrative Law Court's decision dated

March 15, 2024. The Notice of Appeal was timely filed by depositing the same in the United States Postal Service mail on April 12, 2024, and the Respondent was likewise timely served the same day, as proven by the USPS Tracking information included herein (See Attachment 1). Failing to send a copy of the Notice of Appeal to the Administrative Law Court on April 12, 2024, which was corrected the same day it was brought to the undersigned counsel's attention, was a mere oversight and clerical error that did not result in prejudice to the opposing party and, therefore, should not defeat this appeal. See Moody v. Dickinson, 54 S.C. 526 (1899); Connor v. City of Forest Acres, 348 S.C. 454 (2002); Charleston Lumber Co. v. Miller Hous. Corp., 318 S.C. 471 (Ct. App. 1995); and Weatherford v. Price, 340 S.C. 572 (Ct. App. 2000).




