
NOTICE OF APPEAL

Michele Graham, Appellant, intends to appeal the following orders issued by the Honorable Bentley D. Price:

1. The order dated December 22, 2020 granting the Respondent's attorney's fees as to the preliminary injunction hearing (Granted in response to the Respondent's *Motion for Sanctions and Award of Attorney's Fees and Costs Pursuant to SCRPC 65(f)(2).*)
2. The order dated February 16, 2021, denying Appellant's Rule 59(e) motion to reconsider order granting attorney's fees as to the preliminary injunction hearing.
3. The order dated February 28, 2024, providing a more detailed ruling on the Respondent's motion for attorney's fees. This order specifies the Court's re-characterization of the Appellant's Motion for Temporary Injunction as a writ of mandamus and the designation of the Respondent's as the prevailing party of the purported writ.

Appellant received notice of entry of the more detailed and complete order on February 29, 2024.

Given that the February 28, 2024 order provides additional information on the Court's decision-making process and addresses two of the issues raised in Ms. Graham's 59(e) motion, the Appellant filed this appeal upon receipt of notice of this recent, more complete order, in accordance with Rule 203(b)(1) of the South Carolina Rules of Civil Procedure.
