That **MYRON KAREEM SINGLETON** did in Bamberg County on or about June 26, 2020, commit an assault and battery upon [REDACTED] resulting in great bodily injury, and/or the act was accomplished by a means likely to produce death or great bodily injury, to wit: kicking and punching the victim in the head and body until she was unconscious, manually strangling the victim and threatening her with a firearm. All in violation of §16-3-600(B)(1) Code of Laws of South Carolina (1976), as amended.
