

NOTICE OF APPEAL

Donta Kevon Reid appeals his convictions and the sentences imposed by the Honorable John C. Hayes, III. On November 18, 2011, the appellant was found guilty of three (3) counts of Armed Robbery (Indictment Nos.2010-GS-46-0989,2010-GS-46-0990, 2010-GS-46-0991),three (3) counts of Possession of a Weapon During a Violent Crime (Indictment Nos.,2010-GS-0990A, 2010-GS-46-0991A), Criminal Conspiracy (Indictment Nos. 2010-GS-46-0992) and Assault and Battery of a High and Aggravated Nature (Indictment Nos.2010-GS-46-0993). The Appellant was sentenced to thirty (30) years on indictments 2010-GS-46-0989, 2010-GS-46-0990, and 2010-GS-46-0991, five (5) years on indictment 2010-GS-46-0992, and ten (10) years on indictment 2010-GS-46-0993, to run concurrent to each other, and five (5) years on 2010-GS-46-0989A, 2010-GS-46-0990A, and 2010-GS-46-0991A, with this five (5) year sentence to run consecutive to the thirty (30) year sentence.
