**MOTION TO WITHDRAWAL
PURSUANT TO S.C. RULE 260**

COMES NOW the Petitioner, Sara Elizabeth Lindley, by and through her undersigned counsel, pursuant to S.C. Rule 260.

Background and Procedural History

Petitioner Sara Elizabeth Lindley and Respondent Jeffrey Ellicott Lindley were involved in a domestic matter before the Greenville County Family Court in Civil Action No.: 2023-DR-23-0198, *Jeffrey Ellicott Lindley v. Sara Elizabeth Lindley*. Petitioner filed a Motion to Suppress Evidence, arising from issues in the underlying family court matter, in this Court on December 14, 2023.


Subsequent to the filing of her Motion to Suppress, the parties reached a complete and final agreement, resolving all issues in the underlying family court matter in Greenville County Family Court (2023-DR-23-0198) and the issues currently pending in this Court. The parties and their respective attorneys signed the Marital Settlement Agreement (hereinafter “Agreement”) on May 13, 2024. As part of the parties’ Agreement, the pending motion in this Court shall be dismissed with prejudice. The parties appeared before the Honorable Rochelle Y. Conits on May 15, 2024, seeking approval of their executed Marital Settlement Agreement and a final order resolving all issues arising from their marriage and marital litigation.

Conclusion

Based upon the foregoing, Petitioner respectfully requests the following relief:

1. Dismissal of Petitioner’s Motion for Suppression filed December 14, 2024, with prejudice; and
2. For such other and further relief as this Court deems just, fit, and proper.
