**CONSENT MOTION TO DISMISS
PETITION FOR WRIT OF CERTIORARI**

Petitioner, We Are Sharing Hope SC, moves the Court, with the consent of all counsel, to dismiss the petitions pursuant to Rule 242, SCACR, seeking a writ of certiorari to review a final decision of the Court of Appeals dismissing the appeal from an Order Regarding Discovery issued by the Honorable Debra R.
