

ORDER

Appellant filed a notice of appeal challenging a circuit court order dismissing her appeal from a magistrate court's writ of ejection. Respondent moved to dismiss the appeal on January 4, 2024, and February 8, 2024, arguing the appeal is moot because "the eviction of Appellant . . . has been completed." No returns to these motions have been filed. After careful consideration, we grant Respondent's motions to dismiss. *See Sloan v. Dep't of Transp.*, 379 S.C. 160, 167, 666 S.E.2d 236, 240 (2008) (holding that generally, this court "will not pass on moot and academic questions or make an adjudication where there remains no actual controversy"). Remittitur will be sent in accordance with Rule 221(b) of the South Carolina Appellate Court Rules.
