2. I'm a indigent inmate at this time, and I'm kindly requesting counsel to defend the above case in the interest of justice.

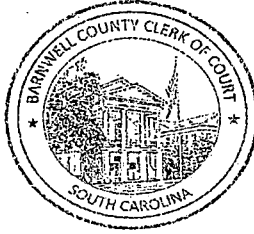
