NOW, THEREFORE, pursuant to Rule 260(b) of the South Carolina Appellate Court Rules, the Appellants and the Respondent mutually agree to forever dismiss this appeal, with prejudice, and to bear their own costs. The Appellants and the Respondent hereby request that this Honorable Court enter an Order of Dismissal, with prejudice, and that a remittitur be sent as provided by Rule 221(b) of the South Carolina Appellate Court Rules.
