This is the first request for an extension of time to file Appellants' Reply to the Response in Opposition to Appellants' Motion to Disqualify Steven L. Smith Counsel for Respondents.



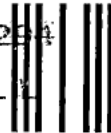
