**MOTION REQUESTING PERMISSION TO  
ORDER TRANSCRIPT OUTSIDE OF FILING  
DEADLINES SET BY RULE 207 OF THE  
SCACR**

TO THE HONORABLE COURT OF APPEALS OF SOUTH CAROLINA:

COMES NOW Appellant, Roberta Moore, pursuant to SC Rules of Appellate Procedure and respectfully requests the Court grant permission to order the transcript outside of the filing deadlines set by Rule 207 of the SCACR because the court ruling on the summary judgment was based on the timeframe of the Appellant's response and the information in the transcripts did not directly address the rationale for the appeal.
