

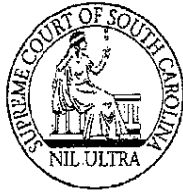

Ms. Holmes:

I am writing in response to your letter received by this office on July 27, 2023, in which you are requesting a copy of your transcript. If you would like to order a transcript of a proceeding that was heard in circuit or family court, **for each hearing**, you must complete the SCCA Form 800, Transcript Request Form, which I have included for your convenience.

To complete the Transcript Request Form, you will need the following information:

1. Case caption (i.e. State v. John Doe)
2. Name of presiding judge
3. County of proceeding
4. Date(s) of proceeding
5. Court reporter name, if available

Once you have completed the form, you may return it to this office or send it to the court reporter directly. Please note that there is no provision for court reporters to prepare and deliver transcripts at no cost to a party. Please refer to Rule 607 of the South Carolina Appellate Court Rules (SCACR), for the current fees charged to all parties for transcription services. In accordance with Rule 607, unfortunately court reporters are not required to retain records after five-years. Additionally, it is helpful to note that court reporters have sixty days to prepare a transcript once satisfactory payment arrangements have been made. They may also ask for up to four (4) 30-day extensions, if they are unable to complete the transcript by the initial deadline.

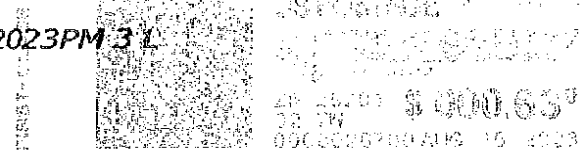

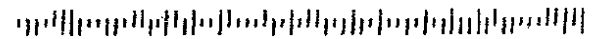
