Transcripts of Plaintiffs' motion for Reconsideration at the October 13, 2022, hearing at the York County Court of Common Pleas before the Honorable Teresa K. Weaver were not recorded and could not be obtained from that court. Court Manager, Robyn Krecek, notified Plaintiffs of a malfunction problem with the recorder preventing a record of the hearing.




