My name is Dominique Alexander Cash. I am an inmate at Kirkland Reception and Evaluation Center. I recently went to trial in Florence County, April 10, 2013, and was found guilty on charges of "Resisting/assault, beat, or wound police officer serving process or while resisting arrest". I am requesting for an appeal on my case because no video evidence was used from the motel lobby where half of the incident occurred, pictures were not taken of the wounds that I received and went to the hospital for, my public defender did not request for a "change in venue" as I asked him to, and my jury was unbalanced towards being bias. I was not rightly judged and was not proven guilty by facts but by opinions, when I am actually still innocent. I also think my dreadlocks and facial hair I grew, waiting in the County Jail to go to trial, played an enormous factor because I had a low hair cut and no beard during the crime I was accused of. I plan to make copies of this letter, so that there is record I requested for an appeal Tuesday April 16, 2013. Please notify me of your disposition as soon as possible. I need a response before April 20, 2013 which is the upcoming Saturday. Thank you all for your help, and may you all be blessed.
