**MOTION FOR FOURTH EXTENSION OF TIME WITHIN WHICH

I.

The Initial Brief of Respondent and Designation of Matter are due to be served and filed on June 5, 2024.

II.

Pursuant to RE: Extension Requests in Criminal Direct Appeals and Post-Conviction Relief Certiorari Proceedings: Order of the South Carolina Supreme Court dated March 18, 2009, the State moves for a **fourth** extension in the above-referenced criminal appeal and asks for an additional thirty days to complete the brief in this case. Since the last extension, counsel has filed a Final Brief of Respondent in The State v. Kareem Lamell Wallace (2023-000544); an

Initial Brief of Respondent and Designation of Matter in The State v. Justin Brodie Granet (2023-000288); and a Brief of Respondent in the South Carolina Supreme Court in The State v. Brandon Jerome Clark (2023-000641).

The undersigned counsel submits this extension request is supported by extraordinary circumstances and is not intended for purposes of delay. The Brief in the above-referenced case has required significant research because the case involves two important issues. The undersigned counsel is currently working on the Brief in this case and intends to have it finished in a timely manner. However, the undersigned counsel has not yet been able to finish the Brief due to a heavy workload. Accordingly, in order to ensure the Brief is properly researched and prepared, I would therefore request an additional extension of time within which to serve and file the Brief.

Please be advised that the State and Appellate Defense continue to consent to any requests for extensions or out-of-time filings. This limited consent applies to requests up to and including June 30, 2024.

WHEREFORE, Respondent prays that the Court extend the deadline for the service and filing of the Initial Brief of Respondent and Designation of Matter in this case for thirty days from the date such relief is granted; hold the matter in abeyance pending a ruling on Respondent's motion; and grant such other and further relief as the Court may deem just and proper.






