This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Sterling Maybin v. The State with the Supreme Court on June 6, 2024. Counsel had an oral


argument in the case of Justin Cone v. The State before the Supreme Court on May 23, 2024. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Derrick Dupree v. The State with the Supreme Court on May 22, 2024. Counsel filed the Return to Petition for Rehearing in the case of Devatee Tymar Clinton v. The State with the Court of Appeals on May 16, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Robert C. Cribb v. The State with the Supreme Court on May 15, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Gerald Ancrum v. The State with the Supreme Court on May 6, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Rishawn Lamar Reeder v. The State with the Supreme Court on April 22, 2024. Counsel filed the Anders Brief of Appellant, Designation of Matter and Record on Appeal in the case of The State v. Latoya Rivers with the Court of Appeals on April 17, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Rodney David Riggins with the Court of Appeals on April 12, 2024. Counsel filed the Anders Brief of Appellant, Designation of Matter and Record on Appeal in the case of The State v. Keyon Prophet with the Court of Appeals on April 3, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Terrance G. Adams v. The State with the Court of Appeals on March 14, 2024.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




