
NOTICE OF APPEAL

DINGLE appeals his conviction for the crimes of Murder (two counts) and Arson, First Degree (two counts) after a jury trial conducted in Sumter County between August 12 through August 14, 2013 before the Honorable George C. James, Jr., presiding. The Appellant received notice of his conviction by the public rendering of the verdict in open court on August 14, 2013 and was subsequently sentenced by the Honorable Judge James to a term of life imprisonment (two counts of murder concurrent) and thirty years consecutive (two counts Arson, First Degree) that same date.
