Please accept this letter as notification of the possible conflicts with the proposed September 10, 11, 12, 24, 25, and 26, 2024 dates or the October 7, 8, 9, 10, 15, 16, and 17, 2024 oral argument dates. The only other cases I am aware of as of the writing of this letter pertaining to a conflict would be an argument in either State v. Bowen G.
