APPELLANTS' MOTION FOR EXTENSION
TO FILE INITIAL BRIEF AND DESIGNATION OF MATTER
TO BE INCLUDED ON APPEAL

Pursuant to Rule 263(b), SCACR, Appellants Tracy Campbell and Daniel Campbell move for an extension of time to file and serve the Initial Brief of Appellants and the Appellants' Designation of Matter to be Included in the Record on Appeal.



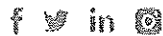
