**APPELLANT'S SECOND MOTION FOR EXTENSION  
TO SUBMIT AMENDED RECORD ON APPEAL AND BRIEFS**

Appellant respectfully requests a second extension, of ten days, to submit the materials described in the Court's order of April 26, 2024. Appellant also wishes the Court to know that Appellant greatly appreciates the Court's previous indulgence with respect to Appellant's psychiatric disorders.
