EXPLANATION OF APPEAL

---

On February 14, 2024, Defendant plead guilty to a Voluntary Manslaughter and Criminal Conspiracy for a negotiated range of 18 to 22 years sentence. He received a 22-year sentence for Voluntary Manslaughter and 5 years concurrent sentence for Criminal Conspiracy.

On February 19, 2024, Defendant moved for reconsideration of the Court's sentence. Defendant argued that the severity of the sentence in light of the additional assistance given to the State, the Defendant's lack of a prior criminal history, and all other pertinent matters of record. State v. Harvey, 123 S.E. 201 (1924).

The Court denied this Motion to Reconsider on May 28, 2024. The Order was received by counsel on June 12, 2024.

Defendant appeals his Sentence and ruling on the Motion to Reconsider.
