Ms. Houston,

I am in receipt of your transcript request for the hearing held on November 27, 2023, before Judge Hayes. I was Judge Hayes's court reporter that day.

I have gone through my file and have estimated the transcript will be about 40 pages. Based on the state page rate of \$4.25 per page, I am estimating the transcript will cost about \$170. The final cost, of course, will depend on the actual final page count.

Our turnaround time for transcripts is 60 days. If you need the transcript sooner than that you will need to order the transcript expedited. The turnaround time for an expedited transcript is seven days and the cost is \$5.00 per page.

Please let me know if you are still wanting me to prepare the transcript. If the transcript is still needed, I can bill your firm when I deliver the transcript. I am assuming you have heard back in regards to the March 27, 2024, hearing. If not,

let me know and I will see if I can track down what is happening with it.
