Dear Honorable Sir

My appeal has been fully briefed and ready for adjudication for over a year, yet still no decision has been reached. The Clerk's Ms. Kitchings and Ms. Harrison granted, in all total, 10 extensions of time to file briefs without either party even alleging "extraordinary circumstances". Not only did these two clerks grant the suspect extensions, but they both have made decisions in law without authorization rejecting my Writs of

habeas corpus in which I was attempting to demonstrate a conspiracy between the Solicitor's Office, Public Defender Office, and a Circuit Court Judge to change a final order in a criminal trial after the term of court had expired.

I was granted a mistrial in my criminal cases on April 15, 2021. It was a final order, and the term of court rule should have been applied. However, Solicitor, Public Defender, and Circuit Court Judge conspired to change the final order, and as a result of this conspiracy I have been wrongfully incarcerated since the final order was changed on June 10, 2021.

An atrocity of justice has occurred, and I have done my best to demonstrate all the corruption that has taken place to cause it. Clerks Kitchings and Harrison have granted unwarranted extensions and exercised judicial power in rejecting my writs of habeas corpus in an attempt to delay justice and prevent me from exposing all the corruption in my case.

Please Honorable Sir, please look

into why my case is being skipped over,  
I was sentenced to 12 years and I  
am scheduled to max my sentence  
out next year. Why am I being  
denied justice. Why are criminals  
being allowed to work in the S.C.  
Judiciary unobstructed with  
impunity? Please Sir look into my  
case

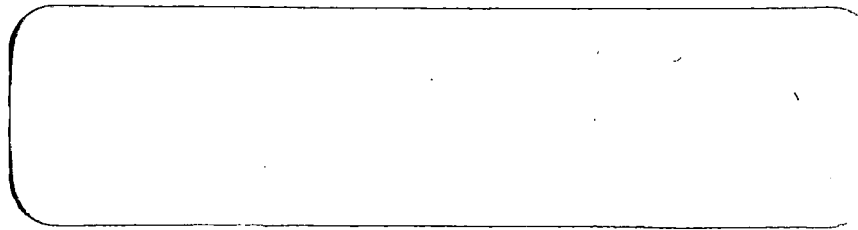
