

At a Court of General Sessions, convened on APR 05 2024, the Grand Jurors of Spartanburg County present upon their oath:

BURGLARY, FIRST DEGREE


(DWELLING)

That the Defendant, Gregory Howard Frye, did in Spartanburg County, on or about April 4, 1997, willfully and intentionally enter the residence located at [REDACTED] [REDACTED], Spartanburg, South Carolina without consent and with the intent to commit a crime therein, and that the defendant did enter the dwelling either:

- (1) in the nighttime; and/or
- (2) armed with a deadly weapon; and/or
- (3) caused physical injury to any person who is not a participant in the crime; and/or
- (4) used or threatened the use of a dangerous instrument; and/or
- (5) displayed what was or appeared to be a knife, pistol, revolver, rifle, shotgun, machine gun, or other firearm.
