**MOTION FOR EXTENSION TO SERVE AND
FILE REPLY TO RESPONDENTS' RETURN TO PETITION FOR WRIT OF
CERTIORARI**

Petitioner's certiorari reply is due Friday, August 23, 2013. Petitioners respectfully request an extension until Monday, August 26, 2013, to serve and file the certiorari reply. Petitioner South Carolina State Plastering, LLC has been coordinating its Reply to Respondent's Return to Petition for Writ of Certiorari with Del Webb Communities, Inc.

and Pulte Homes, Inc. Due to Del Webb Communities, Inc. and Pulte Homes, Inc.'s counsel, Robert Widener, having recently suffered the following:

1. On Tuesday, August 20, Mr. Widener's father experienced heart attack symptoms and was admitted that evening to the University Hospital in Augusta, Georgia.
2. Blood tests ruled out a heart attack but did not explain the symptoms.
3. Mr. Widener was at the hospital with his father all day Wednesday (August 21) and Thursday (August 22).
4. On Thursday (August 22), a heart catheterization revealed two 90% blockages in the right coronary artery, which were treated by inserting two drug-eluting stents.
5. Mr. Widener returned to the office on Friday (August 23) but was unable to finalize the certiorari reply in time to meet the filing deadline.

Del Webb and Pulte have requested a brief extension to serve and file their Reply to Respondent's Return to Petition for Writ of Certiorari. Petitioner South Carolina State Plastering, LLC requests a brief extension to serve and file its Reply to Respondent's Return to Petition for Writ of Certiorari. This extension would make the Reply due August 26, 2013. It is our understanding that Del Webb Communities, Inc. and Pulte Homes, Inc. are also requesting an extension, and we will be coordinating the replies to avoid repetition.
