Dear Madam Clerk:

Along with Jesse Sanchez, Esq. I represent the Petitioner Richard S.W. Stoney in the above matter. We filed our Petition for a Writ of Certiorari with the Supreme Court on May 29, 2024.

In anticipation of receipt of a Return from the Respondent party on or about June 28th, this coming Friday, this letter is to respectfully request an extension of time of ten days to file the Petitioner's Reply.
