**STATUS REPORT AND CONSENT MOTION FOR ADDITIONAL SIXTY-DAY STAY  
OF APPEAL**

Pursuant to Rules 240 and 261(a), SCACR, Appellants and Respondents in the above-referenced appeal jointly move the Court for an additional stay of all deadlines in this appeal for an additional sixty (60) calendar days to allow the Parties to continue to explore the voluntary resolution of the issues in this appeal. On April 30, 2024, the Parties jointly moved for a sixty (60) day extension of all deadlines in this appeal. That motion was granted on May 9, 2024 and the Court’s Order instructed the Parties to “provide this Court with a status update within sixty (60) days.” Since the issuance of the May 9, 2024 Order, the Parties have been engaged in ongoing negotiations but have not yet been able to resolve the issues on appeal. The Parties believe in good faith that the issues on appeal and underlying lawsuit can be potentially resolved with an additional

sixty (60) day stay as requested in this Motion. This additional stay would serve the interests of the parties and judicial economy. Counsel believe in good faith that the sixty (60) day stay requested by this Motion will not unreasonably delay resolution of this appeal. The current deadline for filing Appellants' Initial Brief and Appellants' Designation of Matter in the Record to be Included on Appeal is July 8, 2024. The requested additional 60-day extension would extend this deadline until Friday, September 6, 2024. The extension requested by this Motion would expire on Friday, September 6, 2024.
