

ORDER

This appeal arises out of orders of the circuit court denying Appellants' motions for sanctions/contempt and to recuse. Because the underlying orders are not immediately appealable, this appeal is dismissed. *See Hamm v. S.C. Pub. Serv. Comm'n*, 312 S.C. 238, 241, 439 S.E.2d 852, 853 (1994) (holding discovery orders are interlocutory and not immediately appealable); *Townsend v. Townsend*, 323 S.C. 309, 313, 474 S.E.2d 424, 427 (1996) (holding the refusal of a judge to recuse himself or herself is not appealable until final judgment). The remittitur will be sent as provided by Rule 221(b) of the South Carolina Appellate Court Rules.
