PETITION FOR REHEARING

On June 20, 2024, this Court dismissed without prejudice this matter pursuant to Hudson v. Hudson, 290 S.C. 215, 349 S.E.2d 341 (1986).

**BACKGROUND**

Defendant, Terrionna M. Hartwell, pled guilty to charges of Attempted Armed Robbery and Voluntary Manslaughter on April 25, 2024 before the Honorable Judge Courtney Clyburn Pope in Barnwell County. Defense counsel then filed a Motion to Reconsider Sentencing on May 3, 2024 with the Barnwell County Clerk of Court (see attached Exhibit 1). On May 6, 2024, defense counsel received an email correspondence from the Honorable Judge Courtney Clyburn Pope's law clerk's email denying the defendant's Motion to Reconsider Sentencing (see attached Exhibit 2). On May 14, 2024, defense counsel then filed a Notice of Appeal. On May 28, 2024, defense counsel

received correspondence from the South Carolina Court of Appeals stating that the Notice of Appeal was not accompanied by an order or judgement challenged on appeal. As such, on June 4, 2024, defense counsel filed the Amended Notice of Appeal and supporting documentation to include the email denying defense's Motion to Reconsider Sentencing, and a copy of these filings were hand delivered to the South Carolina Court of Appeals on the same date (see Exhibit 3). On June 24, 2024, defense counsel received in the mail the written order denying defense's Motion to Reconsider Sentencing by the Honorable Judge Courtney Clyburn Pope, which was filed with the clerk of court on June 10, 2024. (see attached Exhibit 4).

### **DISCUSSION**


The Court in Hudson, cites SCRCP 59(e) which states that "A motion to alter or amend the judgment shall be served not later than 10 days after receipt of written notice of the entry of the order." Defense counsel submits to this Honorable Court that this case is now ripe for appellate review and that the Amended Notice of Appeal was submitted within the 10 day requirement. Pursuant to Rule 59(e) for timeliness, the Circuit Court judge made her ruling denying defense's Motion for Reconsideration by means of the email dated May 6, 2024. The original Notice of Appeal that defense counsel filed on May 14, 2024, did not contain the email from the Honorable Judge Pope, which is why the Notice of Appeal was rejected. However, upon receiving correspondence from the Court of Appeals on May 28, 2024, that the original Notice of Appeal was rejected and needed to include the ruling or judgment denying the Motion to Reconsider, defense counsel then submitted the corrected and Amended Notice of Appeal including the email from the Honorable Judge Clyburn Pope and was filed and clocked with the Barnwell County Clerk of Court on June 4, 2024 and hand delivered to the Court of Appeals on the

same date which is within the 10 day requirement of the rule. However, for reasons unknown, the email correspondence from the Honorable Judge Clyburn Pope was not received by the Court of Appeals despite it being hand delivered in the Amended Notice of Appeal Packet.

Additionally, defense counsel now submits the written order denying its Motion for Reconsideration that it received on June 24, 2024 which was filed by the Honorable Judge Clyburn Pope on June 10, 2024. Defense counsel maintains that it included the email stating the Circuit Court judge's ruling on the Motion to Reconsider in its Amended Notice of Appeal on June 4, 2024 and that it was submitted timely pursuant to SCRCF 59(e). We respectfully ask this Honorable Court to grant our petition and reinstate the appeal.

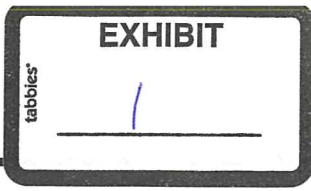
### CONCLUSION

**PROCEDURAL HISTORY**

On April 25, 2024, Terrionna Hartwell appeared before this Court and entered a plea of guilty to Attempted Armed Robbery and Voluntary Manslaughter. Based on prior discussions, it was understood that Ms. Hartwell’s sentence would run concurrent with no other recommendations on sentencing. Following her plea, Ms. Hartwell was sentenced to an active term of imprisonment of twenty (20) years. Ms. Hartwell now asks the Court to reconsider that sentence.

**BIOGRAPHICAL BACKGROUND & MITIGATION**

Ms. Hartwell is twenty-one years old, and received her high school diploma at a military school in South Carolina. Ms. Hartwell was eighteen years old when she was charged with these crimes. Ms. Hartwell has three children, ages one, two, and five years old. She is currently pregnant and due in July of this year with her fourth daughter. Up until the date of her sentencing, she was the primary caregiver for her children. She suffers from a thyroid disorder, which deems her pregnancy to be high risk. As such, she must take daily medication. Up until her sentencing, Ms. Hartwell was a business owner where she ran a clothing line to make clothing for the underprivileged. She has no prior criminal record.

At the time of her arrest, Ms. Hartwell was involved in a romantic relationship with one of her co-defendants, Joseph Freeman. Ms. Hartwell had been dating Mr. Freeman for approximately one year prior to being arrested. Ms. Hartwell maintains that she suffered a great deal of both physical and mental abuse by Mr. Freeman throughout their relationship. When she initially began dating him, she was living with her family in Lexington County, but she eventually moved to Barnwell County with him where they were homeless and living out of a barn. Prior to beginning her relationship with Mr. Freeman, Ms. Hartwell was very close with her family. However, once she moved to Barnwell, she began distancing herself from them as mandated by Mr. Freeman. Ms. Hartwell also maintains that she was instructed by Mr. Freeman not to work a job and that he told her to instead sell nude photographs of herself through an app for them to make money. As was testified to during the plea, many members of Ms. Hartwell's family and friends witnessed the abuse she suffered from Mr. Freeman. Defense counsel would like to make this Court aware that since her sentencing, defense counsel has received a series of text messages that include conversations between Mr. Freeman and Ms. Hartwell directly (Exhibit 1-Text Messages Between Mr. Freeman and Ms. Hartwell), Mr. Freeman and Tonya Freeman, Ms. Hartwell's mother (Exhibit 2- Text Messages Between Mr. Freeman and Tonya Freeman), and conversations between Ms. Hartwell's friends and family members detailing the abuse she sustained at the hands of Mr. Freeman (Exhibit 3 – Text Messages Between Ms. Hartwell's Friends and Family).

Defense counsel would also like to make this Court aware that during Ms. Hartwell's plea, the State rebutted the facts presented in our mitigation and claimed that it had never been reported to law enforcement that Ms. Hartwell was being abused or under duress by Mr. Freeman. However, after the State's rebuttal, defense counsel did not have an opportunity to respond. Upon Ms. Hartwell's arrest and interview with law enforcement, she was still dating Mr. Freeman and


under his influence. She maintains that he made her claim full responsibility and that she was afraid to tell law enforcement otherwise for fear that Mr. Freeman would harm her.

Through her plea of guilt, she admits her wrongdoings and acknowledges the part she played in these crimes. She has taken responsibility and is truly remorseful for her actions. She understands that a life was lost because of her involvement in these crimes and will have to live with this fact forever. However, we respectfully ask this Court to reconsider the fact that Ms. Hartwell has made every effort to turn her life around. (Exhibit 4 – Character Letter). She had no bond violations. She has instead been focused on being a good mother to her children and hopes that she can be present in their lives. When she was arrested, she was very young and impressionable. Had Ms. Hartwell had any idea or belief that any sort of violence would have taken place on that day, she never would have met with the victim. She had no knowledge that any violence or weapons would be present. She was acting on the directions of her abuser. As such, we are asking this Court to take these facts into consideration and show leniency to Ms. Hartwell in light of these points.

### **CONCLUSION**

Based on the foregoing reasons, Ms. Hartwell respectfully requests that this Court reconsider and reduce the sentence imposed.


**ORDER DENYING MOTION TO RECONSIDER SENTENCE**

2021-GS-06-00177, 2024-GS-06-00098

This matter came before the Court on the motion of the Defendant to reconsider the sentences imposed on the above referenced indictments.

On April 25, 2024, Terrionna Hartwell appeared before this Court and entered guilty pleas to the charges of Attempted Armed Robbery (2024-GS-06-00098) and Voluntary Manslaughter (2021-GS-06-00177) with a *recommendation* from the State that the sentences be run concurrently. Following her plea, Ms. Hartwell was sentenced to twenty-five (25) years suspended upon the service of twenty (20) years and five (5) years of probation for Voluntary Manslaughter. On the attempted Armed Robbery indictment, Hartwell was sentenced to a concurrent term of twenty (20) years. Ms. Hartwell now asks the Court to reconsider that sentence.

The Court has carefully reviewed the information submitted in support of the motion to reconsider. After reviewing the information, this Court DENIES the Defendant's motion.
