I KAREN P. POLITE, PRO-SE the (Petitioner) move to Petition this court of Law on July 1,2024 for the VIOLATIONS OF THE JUDGMENT AND FINAL ORDER entered on April 27,2022. That was violated September 9, 2022 By The Attorney ALYSOUN M. EVERSOLE Client, Respondent's Rachel Polite aka Rachel Chaplen. PETITIONER REQUEST FOR **RELIEF FROM SAME for \$100,000** For such other further relief as this Court may render just.

Pursuant to SC Code § 16-3-1700(2)(a)(6)(H)(2023) FIRST"CAUSE OF ACTION" VIOLATION OF "Consent Order, Harassing, Intimidating, Guests, Invitees, Stalking, and Destroying Personal Property,Emotional Stress Karen" file a rule to show " FIRST CAUSE OF ACTION" VIOLATION OF "Consent Order, Harassing, Intimidating, Guests, Invitees and Stalking.

Destroying Personal Property,Emotional Stress towards Karen" and her Personal Property. Karen file a rule to show " FIRST CAUSE OF ACTION" VIOLATION OF "Consent Order, Harassing, Intimidating, Guests, Invitees, Stalking, and Destroying Personal Property,Emotional Stress And Punitive Damage.

The first cause of action Allison ever saw was client Rachel Polite came on to the property on September 9,2022 causing damages to Karen's home, and causing Karen

emotional distress. On September 9, 2022, when Rachel and her children had no right near my home, according to the Judgment and Final order of April 27, 2022. On

November 7, 2022 a motion hearing was held present at the hearing was the Plaintiff, "Rachel M. Polite, Claudia Polite (aka eg. her children ) and Her Attorney, Alysoun M. Eversole. Esq, and Karen P. Polite appearing pro-se". After Rachel testified by saying "her and her children tied a rope behind a truck and pulled the trees from Karen's house at the trial court, on November 7, 2022, according to the transcript the court found " some form of Intimidation and some form of Harassment".

1. "Universal Citation: SC Code § 16-3-1700 (2013) As used in this article:

(A) "Harassment in the first degree" means a pattern of intentional, substantial, and unreasonable intrusion into the private life of a targeted person that serves no legitimate purpose and causes the person and would cause a reasonable person in his position to suffer mental or emotional distress. Harassment in the first degree may include, but is not limited to:"

(2) "visual or physical contact that is initiated, maintained, or repeated after a person has been provided oral or written notice that the contact is unwanted or after the victim has filed an incident report with a law enforcement agency"

(3)" surveillance of or the maintenance of a presence near the targeted person's":

(a) residence;

(4) "vandalism and property damage".

(B) "Harassment in the second degree" means a pattern of intentional, substantial, and unreasonable intrusion into the private life of a targeted person that serves no legitimate purpose and causes the person and would cause a reasonable person in his position to suffer mental or emotional distress. Harassment in the second degree may include, but is not limited to, verbal, written, or electronic contact that is initiated, maintained, or repeated"

The second cause of actions was damage to Karen's home. Karen asked this court to make her whole by ordering the Plaintiff to pay and award Karen the sum amount in damages including, moving expenses of \$48,394 and Punitive Damage \$100,000 to Karen P. Polite.

On Friday September 9, 2022 the Defendant Karen Polite pro-se. reach out to; Beaufort County Court, Courts of Appeal and Ms. Alison Eversole the Attorney for Plaintiff Rachel Polite Chaplin by; email with photos taken at 6 Ladson Road St. Helena Island S.C 29920 about destruction and damage to Karen's property-home.

Karen believes because she was satisfied with the judgment of the bond of August 15, 2022 as ordered by the courts paying more than \$8,000 she should be made whole, because of damages to her home, and emotional distress cause on September 9,2022 by; Plaintiff Rachel Polite and her daughter Claudia Polite (aka her children) for Violating the Final Order and judgment (Rp.61,line 4 transcript) of APRIL 11,2022, present her daughter Claudia Polite (aka her children) tying a rope behind a truck pulling the trees next to Karen's house.

On November 7,2022 at the motion hearing the Plaintiff Rachel in her own defense would testify,

(Rp.43 line 23-25 trans) (R.p. 44 line 1-8 trans) Alysoun Eversole, who also said (R.p.60 line 11-12 trans)" The tree damage ? the tree fell on her place. It did damage the trailer. Eventhough Plaintiff violated the Final judgment Karen continued paying the bond as she was ordered by the courts.

On April 23, 2024 The court ordered Karen home " is in such A condition that it's incapable of being removed from the premises In manner other than by demolition", as described by the Attorney.

On September 5, 2022 Monday Labor Day, I reached out to the Courts and Attorney Alison Eversole about her client Rachel Polite Chaplain guests, and invitees on this property Harassing, Stalking and Intimidating me.

Four days later my home is on the ground with major damage. Broken glass both inside and out.

Television destroyed \$350.00. Two broken house windows \$284.00. Busted pipelines \$140.00. Water damage from the rain inside the home. The front deck completely destroyed

\$2500.00. Cabinets in my kitchen ,and floors value \$8,000, not even 3 years old. My wall interior roof \$280.00. Cost associated with lifting my home is \$7000.

septic tank \$1500 to \$5000

water meter \$1,000 to \$3,000

front deck \$8,920

back deck \$3,920

roof \$1,500

Moving costs \$5000

impact \$ 2500

Total amount of damage \$48,394

Please Award Punitive Damage in thy amount of 100,000
