Which had Me Bed Ridden for Most of The Month of May 2024 and The Majority of June and Due to The Fact I was Unable to submit The Notice of Appeal in The Correct Fromat 7 to My Landlord Back to The Courts. I would like to Ask The Courts to Reconsider This

Judgement. I had Injured My Leg From Falling Through The Decking Boards. This Time That I was in The Emergency Room Had Me in a Situation Where I wasn't Able to Walk or be Home. My Physical Condition was The Reason I Couldn't Submit The Appeal in The Proper Format aswell as Delivering The Copy to Salvatore Scire-Cirneco. This was A Injury That De-railed My Life in Multiple Ways and I Still Currently am In A Leg Brace with Limited Mobility but I have to Prove My Case as I know The Courts Would Find in My Favor I They Would Reconsider and Allow Submission Of My Supportive Evidence with Witnesses. I Also would like to Request a Hearing to Be Released/Relieved of The Judgement of Ejectment. The Missing Supportive Evidence and Witnesses I can Provide to Support My Case!! I Ask The Courts to Favor This

Submission...This is The First and Only Time I would Request An Appeal to The Courts Judgement as I Have Multiple Reasons They Should Resubmit Appeal. I Would Also like to Request A Hearing to Set Aside or Release/Relieve Me of The Courts Ejectment Judgement. He has since threatened to cause harm to me and has broken into the dwelling without notice and still neglects all the mold issues and hazardous issues in the home..I beg the courl to allow my writ to stay ejectment be reinstated with my 600.00 bond. I can only beg the courts to please allow me to pay my court ordered bond from now on to the courts office so I can guarantee this won't happen again. Salvatore has been

terrible and lying about me making my payments wasn't far as I am emailing this to stop a 24 hour notice that blindsided. Me yesterday on my door. He controls our mail box and I never received any notice of him filling to dissolve my bond as he had to have removed it himself. I am still wanting to carry on my appeal and prove to the courts that he has been in the wrong and I know I have done right by the courts and he is not a good landlord.. With having recently found out of a terminal disease I am limited for work and ask the court to proceed without cost as I am in a hardship situation with my family and fighting Salvatore has taken a tole on my Family.
