**MOTION FOR FOURTH EXTENSION OF TIME WITHIN WHICH

I.

II.

Pursuant to RE: Extension Requests in Criminal Direct Appeals and Post-Conviction Relief Certiorari Proceedings: Order of the South Carolina Supreme Court dated March 18, 2009, the State moves for a **fourth** extension in the above-referenced criminal appeal and asks for an additional thirty days to complete the brief in this case. Joseph Eugene Edmond (2023-000799); has filed a Return to Petition for Writ of Certiorari in the South Carolina Supreme Court in Richard A. Dunston, Jr. v. State of South Carolina (2023-001746); and has filed an Final Brief of Appellant and Record on Appeal in the Court of Appeals in The State v. Christopher Stephen Quick (2023-001621).

The undersigned counsel submits this extension request is supported by extraordinary circumstances and is not intended for purposes of delay. The Brief in the above-referenced case has required significant research because the case involves two important issues. The undersigned counsel is currently working on the Brief in this case and intends to have it finished in a timely manner. However, the undersigned counsel has not yet been able to finish the Brief due to a heavy workload. Accordingly, in order to ensure the Brief is properly researched and prepared, I would therefore request an additional extension of time within which to serve and file the Brief.

Please be advised that the State and Appellate Defense continue to consent to any requests for extensions or out-of-time filings. This limited consent applies to requests up to and including July 31, 2024.



Respondent's motion; and grant such other and further relief as the Court may deem just and proper.




